# New Terminal Up & Running!

Tucker, GA terminal is spacious, conveniently located and has room to grow



The newest Marten Terminal facility, in Tucker, GA can accommodate 140 trailers and has more than 150 fenced in driver parking spaces.

TUCKER, GA -- Our new Georgia terminal is up and running! We are very excited to be operating out of this new and spacious facility located in the Stone Mountain Industrial Park in Tucker, GA.

Tucker is located 14 miles northeast of Atlanta and has approximately 26,000 residents. This prime location is a quartermile from Stone Mountain Freeway, which carries dedicated merging lanes to both north and southbound I-285.

The new terminal features over 35,000 square feet of building space and sits on nearly 35 acres of property.

Among the new features of the facility include dual-inspection lanes with indoor fueling, parking for over 140 trailers, over 150 fenced driver parking spaces, a spacious driver's lounge with laptop stations, and spacious bathrooms with showers.

We are now operating over 170 trucks on the Georgia fleet and expect further growth this year and beyond.

This new facility represents a new direction for Marten as we continue our regional growth. We appreciate everyone's hard work as we continue to drive Marten forward.

### **Marten Honored as Best Customer Solution for Environment**

Marten Transport was a recent recipient of the CSX Railway 2009 Pioneer in Intermodal Development Award. "This is an annual award given to the company that reduces the most greenhouse gases through the use of rail long haul and truck delivery at both ends," stated Matt MacPherson, Senior Director Intermodal for Marten Transport. "We are the number one temperature controlled truckload carrier on both CSX and BNSF railways".

According to CSX railway moving freight by rail is three times more fuel efficient than moving freight on the highway. Trains can move a ton of freight more than 436 miles on a single gallon of fuel. Efficient use of fuel means less greenhouse gas emissions for our nation. According to the EPA, freight railroads account for just 2% of U.S. greenhouse gas emissions from transportation sources and well under 1% of greenhouse gas emissions from all sources.

Our leadership positions in Temperature Controlled Intermodal, OTR and Regional gives our customers the opportunity to utilize Marten for all of their freight needs and choose how they want to impact the environment. Without this important environmental friendly Intermodal capability Marten Transport would be losing customer freight to other companies that utilize the rail mode to reduce carbon emissions and save fuel costs.

We are proud to display this award along with many of our other awards at the corporate offices in Mondovi, WI. Next time you pass through, look at our awards wall and understand that Marten Transport is the best all round solution for our customers freight and that Intermodal is a significant contributor to that philosophy.

## **Changes Coming to Indy Terminal** New driver orientation will expand, moving off-site; remodeling in the works

The Indianapolis Terminal will be going through some changes in the coming weeks. Starting last month, orientation is no longer held at the terminal. Instead. orientation will be held offsite at Marten "South", located 1 mile south of the terminal. This new location will be used for recruits to complete their new hire paperwork and to view video conferencing. Road tests and truck assignments will still be done at the Indianapolis terminal because there is no parking available for tractors or trailers at the new facility.

Having orientation off site will allow us to increase the number of recruits in Indv's orientation from nine to 15 recruits. This should help reduce the cost per hire by decreasing travel expenses for new hires. Another advantage to moving orientation offsite is space. For any of you that have been through orientation in Indy or have seen orientation going on, you know that space has been an issue. 9 drivers in the current room means very little space to move around. The new orientation office has a much larger room for video

conferencing as well as additional office's for completing paper work or privacy while discussing any personal information. With the new location being solely for new recruits, there is no concern of interfering with any other department.

The Indianapolis Terminal is also getting a new look. Over the last two years both the Kroger Dedicated fleet and Mid West Regional fleet have grown, but with the restraints of the dispatch office, we are currently at a standstill. With orientation moving offsite, we now have the opportunity to grow.

The floor plan will be completely changed including demolishing the current orientation room and relocating the drivers' lounge to the north side of the building, still allowing 24 hour access from both the front and the back of the terminal.

By doing these renovation we will be able to add office staff to help support both our drivers and our customers.

# **APUs & Hometime**

### UPDATE: Auxiliary Power Unit Policy Revision

Effective immediately Auxiliary Power Units are to be completely shut off when employees go on hometime. All temperature sensitive items (food, medicine, etc) need to be removed from the truck before going home.

The terminal will be doing yard checks and turning off APU's going forward.

Employees who take home-time and leave the tractor at a secure location must do the same.

\* Tractors with Battery Disconnect Switches (Freightliner - Cascadia's and International -Pro Star's) follow these rules while at terminal or home:

If you are taking time off at a terminal or

your home make sure to shut off the Battery Disconnect Switch and make sure the APU is totally off (don't leave it in monitor mode) turn it off completely.

Your batteries will be fine as long as you cut power to them by turning off the battery disconnect switch.

Tractors without Battery Disconnect Switches (all others) follow these rules while at terminal or home:

\* If you are taking time off at a terminal turn your APU completely off.

\* If you are taking time off at your house and it's below 32 degrees consistently then leave your APU in monitor mode. Regional Pay Rate Going Up Regional company
